In the reference fifth cited, the National Commission for Indian System of Medicine, Ministry of AYUSH, Government of India has granted Conditional Permission to Government Siddha Medical College, Palayamkottai, Tirunelveli - 627 002, Tamil Nadu with 125 seats (including EWS seats) in UG (BSMS) Course for the academic session 2021-2022.
