1.	Candidates seeking admission to UG (BSMS / BAMS / BUMS / BHMS) under Government Quota Seats in Govt AUSH Colleges and Government Surrendered seats in Self-Financing AUSH Colleges affiliated to the Tamil Nadu Dr. M.G.R. Medical University, for the academic session 2026-2027 can access the Prospectus and online application form, from the following official website: www.tnayushselection.org .
2.	Application for Tamil Nadu State 2026-2027 UG (BSMS / BAMS / BUMS / BHMS) Medical Course for Government seats and Government Surrendered seats can be submitted online only through the official website of Tamil Nadu AYUSH Selection Committee: www.tnayushselection.org . Application submitted through any other modes will not be entertained.
3.	Qualified and eligible Candidates are required to register ONLINE on the Tamil Nadu AYUSH Selection Committee website www.tnayushselection.org to participate in the Counselling process for allotment of seat. Tamil Nadu AYUSH Selection Committee does not allot any seat manually. (For all General Category Seats).
4.	Use one common application form for all Courses, namely, Bachelor of Siddha Medicine & Surgery [B.S.M.S] Bachelor of Ayurveda Medicine & Surgery [B.A.M.S] Bachelor of Unani Medicine & Surgery [B.U.M.S] Bachelor of Homoeopathy Medicine & Surgery [B.H.M.S]
5.	Candidates are deemed to have read, agreed and accepted this Prospectus and the terms and conditions of the Counselling mentioned in this prospectus for Tamil Nadu State 2026-2027 UG (BSMS / BAMS / BUMS / BHMS) Courses on completing the online submission of application form.
6.	Candidates are advised to read all the instructions carefully, before filling the online Application form, fill up the Application form on their own on the official website [www.tnayushselection.org] of Selection Committee, Directorate of Indian Medicine and Homoeopathy and not through any agent or third party. Any mistake committed by the Candidate will prejudice one's selection.
7.	The Registration Fee for the application form is Rs.500/- (Rupees Five Hundred Only) (non-refundable) and it should be paid through online Bank payment portal in the website. The candidates applying under Special Category for Children of Ex-Servicemen, Eminent Sports Persons, Persons with Bench mark Disabilities (PwD) and Union territories of India (UTI) should pay an additional Fee of Rs.100/- (non-

	refundable) for each Special Category via Bank payment portal. b. All Scheduled Caste/ Scheduled Caste (Arunthathiyar) / Scheduled Tribe Candidates of Tamil Nadu native are EXEMPTED from payment of the cost of the application. c. The last date for submission of online application form will be upto 5:00 P.M. on 31.07.2026. Thereafter there is no provision for the Candidates to submit their online application form. d. Candidates should fill up all mandatory columns, upload all required documents and submit the duly filled in online application. The Candidates may download their filled in online application form and secure a copy of the same for their future reference. Subsequent submission of supporting document(s), is not accepted either by courier / post / or in person.
8.	The admissions in the State of Tamil Nadu are as per the provisions of the Government of Tamil Nadu and in compliance to the National Commission for Indian System of Medicine (NCISM) and the National Commission for Homoeopathy (NCH) and shall be solely based on marks obtained in the National Eligibility-Cum-Entrance Test (NEET (UG) – 2026) conducted by the National Testing Agency (NTA).
9.	As per Chapter-7, Clause 6, para (2) of the NEET Information Bulletin 2026 issued by the National Testing Agency, the Reservation of the Seats in the AUSH Colleges for respective categories shall be allotted as per applicable laws prevailing in the State of Tamil Nadu.
10.	As per prevailing Regulations, the seat matrices for admission in the Government and Self-Financing Institutions shall be 15% for the All India Quota and 85% for the State Quota for the academic year 2026 - 2027 . Further Apportionment of seats between Government and Management of Self–Financing Minority and Non-Minority Indian Medicine and Homoeopathy Medical Colleges will be as per existing State policy and National Commission for Indian System of Medicine (NCISM) and National Commission for Homoeopathy (NCH) regulations and applicable Court orders.
11.	Counselling to Government School students under 7.5 % reservations (as per the Tamil Nadu Admission to Under graduate Courses in Medicine, Dentistry, Indian Medicine and Homeopathy on preferential basis to students of Government Schools Act, 2020 (Tamil Nadu Act No.34 of 2020) will be done ahead of the General Category. The Candidate has to appear in person along with the relevant original certificate at the Selection Committee Office for Counselling.

12. Note for Special Category Claim:

- i. Special Categories (Children of Ex-Servicemen, Eminent Sports Persons, Persons with Benchmark Disabilities, Union Territories of India and Heirs of Hereditary Indian Medicine practitioners) are instructed to submit their applications through online only.
- ii. At the time of filling the online application, Special Category Candidates are required to mention the respective Special Category Code Number as mentioned in the Annexure-I and upload the necessary supportive documents as mentioned in the below table.

- iii. One Candidate can apply a maximum of three Special Categories. For each Special Category Rs.100/- has to be paid separately through online portal. The claim under Special Category will not be considered, under any circumstances without the required documents.
- iv. Special Category rank differs completely from that of the General Category rank.
- v. Special Category Candidates cannot claim the same rank in the General category and vice versa.
- vi. All the Special Category Candidates should submit the hard copy of their online application form along with the relevant supportive documents to the address mentioned below.

Candidates applied under the Eminent Sports Person category will be called in person (Date and time will be intimated through the Official Website of Selection Committee) with their original Sports Certificates and relevant documents along with the hard copy of their online application form for Certificate Verification.
- viii. The claim under Special Category will not be considered, under any circumstances without the required documents and the application of such

	Candidate shall be considered under General Category only, if Candidate fulfils the norms for the General Category. ix. Counselling for the Special Categories will be done before the General Category online Counselling. The Candidate has to appear in person along with the relevant original certificates at the Selection Committee Office for all Special Category Counselling. x. In case of unavoidable circumstances Special Category Candidates can authorize his/her Parents/Guardian on his/her behalf for Counselling. The Parent's/Guardian's decision will be binding on the Candidate. 1.	ELIGIBILITY CRITERIA Candidate should be a citizen of India. Foreign nationals are NOT eligible to apply for admission to AUSH Medical Degree Courses.
2.	NATIVITY i. Candidate should be a Native of Tamil Nadu. ii. Other State Candidates who have studied from VI Standard to XII Standard continuously in Tamil Nadu, have to produce their School Bonafide Certificate from the School in which Candidate studied VI Standard to XII Standard will be considered under the Open Category. Note: a. Candidates who are native of Tamil Nadu studied from VI to XII Std. either partly or completely in Schools situated outside Tamil Nadu should upload the “Nativity Certificate”. Such Candidates should also give an undertaking that they have not applied for any Educational Institution in any other States, claiming the nativity of such State for admission. If it is found later that the Candidate has applied as a native of any other States other than Tamil Nadu, then the admission will be cancelled at any stage. Further, even during the Course of study if it is subsequently found that any Candidate has produced a false Nativity Certificate or given a false undertaking, it will result in expulsion of the Candidate from the Course and also initiation of criminal proceedings against the Candidate as well as his/her Parents as per provision of the law. b. The Certificate of Nativity in Tamil Nadu should be issued by the competent Authority only in the specified format available (ANNEXURE IV) in the Prospectus. c. Applications without a proper Nativity Certificate will not be considered. d. Candidates belonging to other States and residing in Tamil Nadu cannot claim nativity of Tamil Nadu. e. Permanent Residence Certificate in lieu of Nativity Certificate will not be accepted. f. Foreign Nationals are NOT eligible to apply for admission to B.S.M.S./B.A.M.S./B.U.M.S./ B.H.M.S. Courses 2026 - 2027 session.

	g. Producing false Nativity Certificate if detected at any time later during the Course of Study will result in expulsion of the Candidate and also initiation of criminal proceedings against the Candidate as well as the Parents as per law. h. The Nativity Certificate obtained previously or e-Nativity Certificate obtained in the latest updated format issued not below the rank of Zonal Deputy Tahsildar of the concerned Revenue Jurisdiction is accepted. i. Community Certificate obtained from other States will not be considered for reservation and such Candidates will be treated as open category.												
3.	AGE LIMIT (For Details kindly refer clause 6.1.1. of NEET UG – 2026 Bulletin) No Candidate shall be admitted to BSMS / BAMS / BUMS / BHMS Degree Course unless one has attained the age of Seventeen Years on or before the 31st December, 2026 of his/her admission to the first year of the Undergraduate AYUSH Courses and there is no upper age limit. (Evidence for the age e.g., birth certificate, 10th mark Sheet should be uploaded).												
4.	COMMUNITY CERTIFICATE: a. EDUCATIONAL QUALIFICATIONS (i) Admissions to all State Quota seats of Undergraduate Ayurveda, Siddha, Unani and Homoeopathy Courses will be done through NEET (UG) – 2026 as per the provisions of the National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Ayurveda Education), Regulations 2022, National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Siddha Education), Regulations 2022 and National Commission for Indian System of Medicine (Minimum Standards of Undergraduate Unani Education), Regulations 2022 and National Commission for Homoeopathy (Homoeopathy Graduate Degree Course – BHMS), Regulations 2022. NCISM (NATIONAL COMMISSION FOR INDIAN SYSTEM OF MEDICINE) & NCH (NATIONAL COMMISSION FOR HOMOEOPATHY) are Regulatory Bodies of the above-mentioned Courses under the Ministry of AYUSH. (ii) In order to be eligible for admission to BSMS / BAMS / BUMS / BHMS Degree Courses for this academic year, it shall be necessary for a Candidate to obtain minimum of marks at 50th Percentile in NEET UG-2026. However, in respect of Candidates belonging to Scheduled Tribes, Scheduled Castes, Scheduled Castes (Arunthathiyar), Backward Classes, Backward Classes (Muslim) and Most Backward Classes / Denotified Communities, the minimum marks shall be at 40th Percentile in NEET UG-2026. In respect of Candidates with Benchmark Disabilities specified under Rights of persons with disability Act 2016, the minimum marks shall be at 45th Percentile for General Category Candidates and 40th Percentile for ST / SC / SCA / MBC / DNC / BCM and BC Candidates in NEET UG-2026.

	Note: Provided further that where sufficient number of Candidates in the respective category fail to secure minimum marks in the National Eligibility – cum – Entrance Test held for any academic year for admission to Undergraduate programme, the National Commission for Indian System of Medicine & National Commission for Homoeopathy, in consultation with the Central Government may at its discretion lower the minimum marks required for AUSH admission to Undergraduate programme for Candidates belonging to respective category and marks so lowered by the Central Government shall be applicable for that academic year only. Course, to become eligible to take the other subjects’ examination of the B.U.M.S. Course.
6.	INELIGIBILITY CRITERIA The following categories of Candidates are NOT ELIGIBLE to apply for B.S.M.S. / B.A.M.S. / B.U.M.S. / B.H.M.S. - e) A Candidate who has allotted a seat but not joined or joined the College but discontinued the Course within the stipulated date (the date before the start of the 3rd round of online Counselling registration) will be eligible to attend the subsequent Rounds of online Counselling for the academic year 2026-2027

(iv) ROUND 2 OF ONLINE COUNSELLING:

- a) After completion of Round 1 of online Counselling, the remaining vacancies will be filled with the Candidates from the existing Provisional Merit list by Round 2 online Counselling. Candidates who wish to retain their allotted seats and do not want a change in College are not required to participate in Round 2.
- b) Candidates who have not allotted any seat / allotted a seat, but did not join in the College/ allotted a seat and joined in the College but discontinued from the Course, i.e., before Round 2, will remain eligible to participate in Round 2. (v) Virtual vacancies:

- a) If a Candidate allotted a seat in Round 1 opts for upgradation in Round 2, that Round 1 seat will be displayed as a virtual vacancy.

- f) The payment of the online processing Fee is not mandatory for:

 - (ii) Not-joined Candidates
 - (iii) Unallotted Candidates

Note:

- a) Candidates who joined in Round 3 of All India Quota or State Quota shall not be eligible to participate in the further Rounds for All India Quota or State Quota for this academic year (i.e.) 2026 - 2027 as per information bulletin NCISM.
- b) Once a Candidate has joined the seat allotted in Round 3, they will not be allowed to upgrade or participate in the further rounds of Counselling for the academic year under any circumstances. (I - B) World Championship, Commonwealth championship, World Cup- (organized in 4 Years frequency by the International Sports Federations).

Eligibility for athletes requires participation in an event involving at least seven different countries and such competitions should have been approved by Indian Olympics Association (IOA), Sports Authority of India (SAI) and Ministry of Youth Affairs and Sports (MYAS).

CATEGORY - II

World Championship, World cup, Asian Championship, SAF Games (South Asian Games), Commonwealth championship Organized in 2 years frequency by the International Sports Federation.

Eligibility for athletes requires participation in an event involving at least seven different countries and such competitions should have been approved by Indian Olympics Association (IOA), Sports Authority of India (SAI) and Ministry of Youth Affairs and Sports (MYAS).

Open or Invitational or Memorial or any indifferent nomenclature or title of tournaments or Championships at International level, not approved by any of the above Authority will not be considered for marks.

CATEGORY - III

Asian Championships, Commonwealth Games, World cup, World Championship, Grand Prix, Grand slam - Organized in Every year by the International Sports Federation.

Eligibility for athletes requires participation in an event involving at least seven different countries and such competitions should have been approved by Indian Olympics Association (IOA), Sports Authority of India (SAI) and Ministry of Youth Affairs and Sports (MYAS) Government of India.

1. Participation or achievement in International tournaments will be considered only with earlier achievements at National and State level tournaments. Direct participation / Selection trials / Camps any International or National tournaments will not be considered for award of marks.
2. The highest achievement in only one annual regular tournament, officially conducted in a regular manner by the member National Olympic Committee (NOCs) authorized by the

International Olympic Committee (IOC) or International Sports Federations affiliated to the IOC will be considered for award of marks. The players /sports persons representing the Country in such tournaments through Indian Olympic Association (IA) or respective National Sports Federations recognized by the Ministry of Youth Affairs and Sports, Government of India or IOA will be considered for award of marks in each year.

3. Only tournaments officially recognized by the Indian Olympic Association / respective official National Sports Federations Recognized by MAYS will be considered for the award of marks (for each year) from 01.06.2021 to 31.05.2022, 01.06.2022 to 31.05.2023, 01.06.2023 to 31.05.2024 and 01.06.2024 to 31.05.2026.
4. Certificates of Participation or Achievements in tournaments, submitted along with Form I alone are eligible for marks indicated in Table (I) above (should be submitted before the last date for submission of application).
5. Players who participated in any of the categories I, II and III, in Table(I) should produce the copies of the following: -
 - i. VISA, Immigration entry in passport, clearance from Ministry of Youth Affairs and Sports (Government of India), Indian Olympic Association and respective National Sports Federations including BCCI.
 - ii. The fixture, draw, schedule of events, players' accreditation, National Medal, Merit, Diploma, Participation certificate and Form-I issued by the respective National Sports Federation and certificates signed and issued in the prescribed format by the President or Secretary General of the National Olympic Committee of the Organizing Country and International Sports Federation.

4 (b). FOR NATIONAL TOURNAMENTS

1. National tournaments should have been officially be recognized as the regular annual championship / tournament by MYAS or IOA or SAI or SDAT or SGFI Nationals conducted every year by School education department in age groups (U-14, U-17, U-19) or respective official National Sports Federation will be considered (for each year) for the award of marks.
2. Marks will not be awarded for selection trials and coaching camps.
3. Tournaments conducted by the Federations which are not recognized by the IOA or MYAS, TNOA or SDAT at National level for a particular period will not be considered for award of marks.
4. Candidates must have participated at Zonal Cluster, District, Regional, State, National and International in a particular Game/Sport in the same hierarchical order as per the existing norms applicable for a particular Game/Sports.

National or State Level Championships or Tournaments conducted by Sports Federations or Associations recognized by MYAS or IOA or SDAT or TNOA alone will be considered for the award of marks. (Recognition of State Associations / National Federations should be relevant to the year concerned).
3. Relevant attested copies of certificates issued by the competent authorities as detailed below are to be submitted along with the application before the last date for receiving the applications.
4. Open or Invitational or Memorial or any indifferent nomenclature or title of tournaments

- or Championships at District or State or National or International level will not be considered for marks.
5. District or Inter-District Championship means the championships conducted by the respective recognized District or State Sports Association for the State of Tamil Nadu.
 6. Direct participation or achievement at any level without participating in the qualifying level competitions such as District or State or National or direct selection conducted by District or State Sports Association or National Sports Federation to represent the District or State or National or International tournaments or championships will not be considered for award of marks.
 7. For International achievements in Tennis, marks for Gold, Silver and Bronze will be awarded to players who are ranked first, second and third respectively in the ATP or WTA rankings of International Tennis Federation for awarding participation marks for the top 5 ranked players will be considered from the ATP or WTA list published by the International Tennis Federation. Necessary document and proof should be enclosed by the Candidate for National or State level achievement in Tennis, marks for Gold, Silver and Bronze will be awarded to players who are ranked first, second and third respectively in the AITA or TNTA at National or State for awarding participation mark the top 5 ranked players will be considered from the list published by AITA or TNTA at National or State level based on the ranking. Necessary documents and proof should be enclosed by the Candidate.

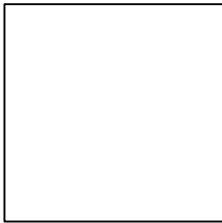

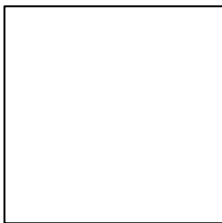

FAQ'S REGARDING COUNSELLING PROCESS

Q.No.1: How to apply for AUSH UG Medical Degree Courses admission in Tamil Nadu?

Ans: After the NEET-UG2026 results are out, there will be notification in the website www.tnayushselection.org, for application to AUSH UG Medical Degree Courses admission in Tamil Nadu. Candidates are advised to Register them to create User Name and Password after that login using their User Name and Password. Candidates are advised to read this prospectus carefully and apply through the website in Online mode only.

Note: Cost of applying online: Rs.500/- (SC/SCA/ST Candidates are exempted)

Q.No. 2: I have applied online. Is this enough for getting a seat?

Ans: No. Applying online is just the first stage in the entire process. Once all the applications are received and scrutinized Eligible Merit List of Candidates (Candidates who have applied and are found eligible) will be published in the website. After this Candidates have to register for the Counselling process as mentioned in the scheme of Counselling.

Q. No. 3: How do I register for the Counselling?

Ans.: After the Merit List is published Candidates have to register before the onset of Counselling by paying the non-refundable online Processing Fee of Rs.500/- in the website after logging in using the same credentials (User Name, Password) used during the application process. Registration is allowed before Round 1, Round 3 and Stray Round and Fresh registration is not allowed before Round 2 (as this is a re-allotment Round)

Note: Counselling Registration is allowed only for already applied Candidates who are in the Eligible Merit list and not for those Candidates who have not at all applied to AUSH UG Medical Degree Course.

Q. No. 4: How and when I had to make the payment?

Ans: After completion of Choice filling, payment page appears automatically. Candidate can do online payment by Net Banking / Credit card/ Debit card. Only after the successful payment, Candidate can submit their choice filling.

Q. No. 5: Is there any restriction for filling up number of choices of Institution (College) in choice filling form?

Ans: No, you can give as many choices as you wish during online choice filling. However, choices should be in order of your preference. There will be a common software for Government Quota / Government Surrendered seats for filling up of choices. The choices will be available based on your eligibility and application.

Q. No.6: Is it necessary to fill up the choices and lock the choices to get seat allotted? Or I will be allotted seat automatically from leftover seats?

Ans: After online registration (registration is compulsory to take part in online allotment process, before the Counselling Rounds during specified registration period), you have to fill in choice of Institution/College/Course in order of your preference. Once choice is filled in, it can be modified before locking it. If Candidate does not lock the choice submitted by him/her, the choices already filled will be automatically locked as per Counselling schedule.

Note: If the Candidate does not fill choices for any College, will not be allotted any seat during the Counselling

IMPORTANT:

Don't wait till the last minute to Register and Lock your choices. Please go through your submitted choices before locking, as once you lock the choices they cannot be modified or changed even if you have made a mistake. It may result in allotment of a seat which you never wanted. (Please note that the choices once locked cannot be unlocked even by the Selection Committee)

Q. No. 7: Is it necessary to join allotted College of Round 1 to get chance to participate in Round 2?

Ans: No, Candidates need not report or join the allotted College of Round 1 since there is free exit. However, if they want to retain the Round 1 seat and upgrade in Round 2 they have to physically join the College of Round 1 and participate in Round 2 online.

Q. No. 8: Can a Candidate participate in Round 2 without submitting fresh choices (based on choices submitted before Round-1)?

Ans: Fresh choice submission by eligible Candidates, as mentioned above is necessary for consideration for seat allotment during any Round. If Candidate does not submit fresh choice(s) during choice filling period, the Candidate will not be considered for allotment of seat during Round- 2 and will retain the already joined seat, if any

Q. No.9: If I opt to participate in Round 2 of Counselling whether my allotted seat

(of Round 1) will be cancelled?

Ans: In case you are not allotted any seat in the Round 2, you will retain earlier allotted seat in Round 1 if you had joined already. However, on re-allotment of a seat in Round 2, the earlier allotted seat in Round 1 will automatically be cancelled and allotted to another Candidate. Therefore, you are advised to fill in only choices which you prefer over the earlier allotted seat, for Round 2.

Q. No. 10: - What is the procedure for Round 3 Counselling which will be conducted by Tamil Nadu AYUSH Selection Committee for AUSH Medical Degree Courses?

Ans. Since reallotment is allowed in Round-3, The net vacant seats due to Not allotted / non joining, non-reporting of Round 2 and any converted seats due to lack of Candidates in the particular quota and the virtual vacancies will be published in the seat matrix and eligible Candidates have to **submit fresh choices** and the result will be processed as per Choice & Merit applying the rule of Reservation.

Q. No. 11: How much time will I be given to join the allotted College?

Ans: Candidates allotted seats will be required to join the allotted College/Course within the stipulated time which is mentioned in Counselling schedule. However, Candidates are advised to join as early as possible and not to wait for last day of joining, due to different schedule of holiday (including local holidays) / working hours in various ISM Medical Colleges. Therefore, Candidates are advised to contact allotted College immediately after declaration of result of Counselling allotment process, to know the details. If Candidate fails to join the allotted College within stipulated time, then the allotted seat will be cancelled. For Round 3 and Stray Round as there is very little time for the entire Counselling process and there is no process of reallotment/resignation, downloading of Allotment Order after payment of Tuition Fee will be considered as Joined. But the Candidate has to report to the allotted College within the stipulated time. If the Candidate does not report Candidates will be treated as Discontinued and his seat will be considered vacant and Candidates will forfeit the advance Tuition Fee. Please note that under no circumstances date of joining/date of reporting can be extended by the Selection Committee.

Q. No. 12: What documents are required at the time of Joining/ Reporting to allotted College?

Ans: The following original documents (along with attested photocopies) are required at the time of joining/reporting to the allotted College:

- i. Class X Mark Sheet
- ii. Class XI Mark Sheet
- iii. H.S.C. Mark sheet or any other equivalent examinations.
- iv. Transfer certificate obtained after the completion of H.S.C / equivalent examination or any other Courses.
- v. Certificate for proof of study from VI Std. to XII Std for the Candidates who have studied completely in Tamil Nadu.
- vi. Community Certificate
- vii. Nativity Certificate.
- viii. Eligibility Certificate (if applicable)
- ix. Migration certificate (if applicable)
- x. Special Category Certificate (if applicable)

Q. No. 13: In case candidate had to apply for Govt. Quota, All India Quota and management quota in SF Colleges, should the candidate pay the fee for all?

Ans: Yes. As per the policy, the Candidate has to pay the prescribed fees for all Quotas applied for. In such cases, the Candidate shall pay the following fees:

- For Government Quota (GQ) seats in Self-Financing Colleges – Rs.10,000/- as Advance Tuition Fee.
- For each of the All India Quota (A.I.Q.) and Management Quota (M.Q.) – Rs.25,000/- as Advance Tuition Fee.
- In addition, all the Candidates should pay the Online Processing Fee of:
